#### EXPLANATORY NOTE

Pursuant to General Instruction E to Form S-8 under the Securities Act, this Registration Statement is filed by Matinas BioPharma Holdings, Inc. (the "Company") for the purpose of registering additional shares of the Company's common stock, par value \$0.0001 per share (the "Common Stock") under the 2013 Plan. The number of shares of Common Stock available for issuance under the 2013 Plan is subject to an automatic annual increase on January 1 of each year beginning in 2015 equal to 4% of the number of shares of Common Stock outstanding on December 31 of the preceding calendar year or a lesser number of shares of Common Stock determined by the Board of Directors of the Company (the "Evergreen Provision"). This Registration Statement registers an aggregate of 3,734,846 additional shares of Common Stock available for issuance under the 2013 Plan as a result of the Evergreen Provision.

The shares of Common Stock registered pursuant to this Registration Statement are of the same class of securities as the shares of Common Stock registered for issuance under the 2013 Plan pursuant to the currently effective Registration Statement on Form S-8 (Registration No. 333-198488) filed on August 29, 2014, Registration Statement on Form S-8 (Registration No. 333-203141) filed on March 31, 2015, Registration Statement on Form S-8 (Registration No. 333-210495) filed on March 30, 2016 and Registration Statement on Form S-8 (Registration No. 333-215456) filed on January 6, 2017. The information contained in the Registrant's registration statements on Form S-8 (Registration Nos. 333-198488, 333-203141, 333-210495 and 333-215456) is hereby incorporated by reference pursuant to General Instruction E.
